A copy of your entry status documentation that reflects your current or prior status as a refugee, an asylee, or as a victim of human trafficking who entered the United States after the age of 15.

Proof of your attempt to obtain documentation of your completion of a high school education in a foreign country. You may send a letter or email to the Ministry of Education or your country's embassy in the U.S. You may receive a letter or email in response confirming that you are unable to obtain your transcripts from your native country. If no response is received after 30 business days, a copy of the email or letter, including proof of mailing, can be submitted to the college as proof of their attempt to obtain documentation.
